RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of January 12, 2022 (the “Effective Date”), is made by Cerberus Business Finance Agency, LLC, a Delaware limited liability company (the “Releasor”), in favor of Dent Enterprises, LLC (the “Releasee”).

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of July 9, 2021 (the “Trademark Security Agreement”), Releasee pledged to the Releasor for the benefit of the Secured Parties, and granted to the Releasor for the benefit of the Secured Parties, a Lien on and security interest in, all of its right, title and interest in, to and under the following Collateral owned by the Releasee (the “Trademark Collateral”):

- (a) all of its U.S. Trademarks, registrations and all applications for registration thereof, including, without limitation, those referred to on Schedule A hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, or other violation thereof; and

WHEREAS, the security interest granted in the Trademark Security Agreement was granted in conjunction with the security interest granted to the Releasor pursuant to that certain Guaranty and Security Agreement, dated October 7, 2019, in favor of Releasor.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Credit Agreement, dated as of October 7, 2019.
2. Release of Security Interest. Releasor, without representation, warranty or recourse, hereby releases, relinquishes, terminates, cancels and discharges its Lien on and security interest in the Trademark Collateral, and authorizes the recordation of this Release with the United States Patent and Trademark Office.
