AGREEMENT REGARDING TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS AGREEMENT REGARDING TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Termination"), is dated as of July 29, 2022 (the "Effective Date"), and made by **MONROE CAPITAL MANAGEMENT ADVISORS, LLC**, in its capacity (in such capacity, "Grantee") as administrative agent for and on behalf of the Lenders as defined in that certain Credit Agreement dated May 2, 2017 by and among Grantee, Curion, LLC (formerly known as Q Research Solutions Holdings, LLC), a Delaware limited liability company ("Grantor"), and others party thereto, in favor of Grantor.

WHEREAS, pursuant to that certain Guaranty and Collateral Agreement dated as of May 2, 2017 by and among Grantor, Grantee, and others party thereto (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), and the Trademark Security Agreement dated as of May 2, 2017 by and among Grantor and Grantee ("Trademark Security Agreement"), Grantor granted to Grantee, for itself and the ratable benefit of the Lenders and their Affiliates, a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral, including the Trademarks listed on Exhibit A hereto (collectively, the "Released IP");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office ("USPTO") on May 3, 2017 at Reel 6052 Frame 0066; and

WHEREAS, Grantee desires to terminate and release its security interest in and with respect to the Released IP effective as of the Effective Date.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. Capitalized terms used herein are used as defined in the Security Agreement or Trademark Security Agreement, as applicable.
2. Release of Security Interest. Effective as of the Effective Date, Grantee hereby terminates, releases and discharges its continuing security interest in all of Grantor's right, title and interest in, to and under the Released IP, and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in all of the foregoing.
3. Authorization. Grantee authorizes the recordation of this Termination with the USPTO at Grantor's expense.
