### INTELLECTUAL PROPERTY ASSIGNMENT



Assignor authorizes the United States Patent and Trademark Office to issue any patents resulting from the Patent Application to Assignee. The right, title, and interest is to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignor had this assignment not been made.
3. Further Assurances. Assignor shall timely execute and deliver any additional documents and perform such additional acts necessary or desirable to record and perfect the interest of Assignee in and to the Trademark, the invention, the Patent Application and any patents granted thereto.


