**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 29, 2022 (“Release”), is made by Bank of America, N.A., as Administrative Agent (“Administrative Agent”) in favor of Mechanical Solutions, Inc., a Texas corporation (“Grantor”).

WHEREAS, pursuant to that certain Collateral Agreement dated as of September 1, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Grantor, Administrative Agent, and others party thereto, and the Trademark Security Agreement dated as of September 1, 2017 by and among the Grantor and Administrative Agent (“Trademark Security Agreement”), Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in all right, title and interest in, to or under the Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on September 1, 2017 at Reel 6145 Frame 0547; and

WHEREAS, Grantor and Administrative Agent have determined that the Trademark Collateral listed on Schedule A attached hereto was not owned by Grantor and the security interest in the Trademark Collateral listed on Schedule A attached hereto was granted in error.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Collateral Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. To correct the erroneous grant of security interest, Administrative Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:


(a) terminates, cancels, discharges, and releases the security interest in all right, title and interest in, to or under solely the Trademark Collateral listed on Schedule A attached hereto, granted pursuant to the Collateral Agreement or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
