
ASSIGNMENT OF TRADEMARK

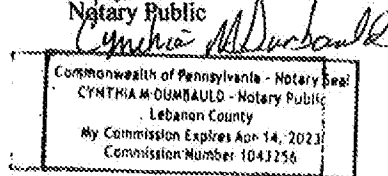

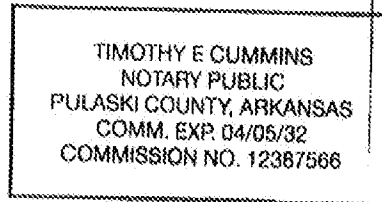
