**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 4, 2022 (“Release”), is made by Alter Domus (US) LLC, as collateral agent (the “Collateral Agent”), in favor of Casting Networks, LLC (the “Grantor”).

**WHEREAS**, the Collateral Agent, certain Issuers and the Grantor have entered into that certain Note Purchase Agreement, dated as of November 19, 2020 (as amended, restated, amended and restated, replaced, supplemented, or otherwise modified from time to time, including all annexes, exhibits and schedules thereto, the “Note Purchase Agreement”);

**WHEREAS**, the Collateral Agent and the Grantor have entered into that certain Security and Pledge Agreement, dated as of November 19, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, including all schedules and exhibits thereto, the “Security Agreement”);

**WHEREAS**, pursuant to that certain Trademark Security Agreement, dated as of November 19, 2020, by the Grantor (the “Trademark Security Agreement”), the Grantor as collateral security for the prompt and complete payment and performance when due of the Secured Obligations of the Grantor, mortgaged, pledged and hypothecated to the Collateral Agent and granted to the Collateral Agent a Lien on and security interest in all right, title and interest of the Grantor in, to and under the Trademark Collateral, including the Trademark Collateral listed on Schedule A attached hereto (the “Trademark Collateral”);

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) at Reel 7111 Frame 0295 on November 19, 2020;

**WHEREAS**, the Grantor has satisfied the terms of the Trademark Security Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

**SECTION 1. Defined Terms.** All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

**SECTION 2. Termination and Release.** The Collateral Agent, without representation, warranty, or recourse, hereby:

(a) terminates the Trademark Security Agreement and terminates, cancels, discharges, and releases the Security Interest, whether granted pursuant to the Security Agreement or Trademark Security Agreement, including to the Trademark Collateral;

(b) assigns and transfers to the Grantor all of its right, title and interest in and to all Trademark Collateral, whether granted pursuant to the Security Agreement or Trademark Security Agreement (including the Trademark Collateral listed on Schedule A attached hereto), together with the goodwill of the business symbolized thereby; and


(c) authorizes the recordation of this Release with the USPTO or any similar office or agency within or outside the United States at the Grantor’s expense.

The Collateral Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Collateral Agent has caused this Release to be duly executed as of the date first set forth above.


