ASSIGNMENT OF TRADEMARK

WHEREAS, SMART CART, LLC, whose address is 3435 WILSHIRE BLVD., STE. 1100, LOS ANGELES, CALIFORNIA 90010, hereinafter referred to as "ASSIGNEE," is desirous to acquire the entire right, title and interest in and to the same Trademark in the United States of America and its territorial possessions;

WHEREAS, ASSIGNOR further covenants that no assignments, sale, agreement or encumbrance has been, or will be made or entered into, which would conflict with this Assignment;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR by these presents does assign and transfer unto said ASSIGNEE, the entire right, title, and interest to said Trademark throughout the United States of America, and its territorial possessions, including all priority rights available under any applicable International Convention.

ASSIGNOR and ASSIGNEE also hereby specifically agree that by this agreement, ASSIGNEE acquires the following: (1) all the property, right, title and interest in and to the Trademark including all common law rights connected therein together with the applications therefor for the United States and throughout the world together with the goodwill of the business in connection with which the Trademark is used and which is symbolized by the Trademark; (2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Trademark, including without limitation, damages, and payments for past or future

infringements and misappropriations of the Trademark; and (3) all rights to sue for past, present and future infringements or misappropriations of the Trademark.

ASSIGNOR hereby agrees to execute any documents that legally may be required in connection with the maintenance of said registration in the United States of America for said Trademark, including additional documents that may be required to affirm the rights of ASSIGNEE in and to said Trademark, all without further consideration, other than the consideration provided by ASSIGNEE pursuant to this agreement.

ASSIGNOR also agrees, without further consideration and at ASSIGNEE'S expense, to identify and communicate to ASSIGNEE, at ASSIGNEE'S request, documents and information concerning the Trademark that are within ASSIGNOR'S possession or control, and to provide further assurances and testimony on behalf of ASSIGNEE that lawfully may be required of ASSIGNOR in respect of the prosecution, maintenance, litigation and defense of the TRADEMARK encompassed within the terms of this instrument.

ASSIGNOR'S obligations under this instrument shall extend to ASSIGNOR'S heirs, executors, administrators and other legal representatives.




