TRADEMARK ASSIGNMENT AGREEMENT

Assignor also assigns unto Assignee all claims for relief by reason of any past infringements of such Marks, with the right to sue for and collect damages for Assignee's own use and benefit, and for the use and benefit of Assignee's successors, assigns and other legal representatives.

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office, and in any applicable jurisdictions outside of the United States, to record this assignment. Assignor agrees to further execute any documents reasonably necessary to effect this Assignment, or to confirm Assignee's ownership of the Marks.
