Assignor does hereby assign and transfer to Assignee: (1) all the property, right, title and interest in and to the Trademarks including all common law rights connected therein together with the registrations therefor for the United States and throughout the world together with the goodwill of the business in connection with which the Trademarks are used and which is symbolized by the Trademarks; (2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Trademarks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Trademarks; and (3) all rights to sue for past, present and future infringements or misappropriations of the Trademarks.
2. Acceptance. Assignee hereby accepts the foregoing assignment.
3. Consideration. The consideration to be paid by Assignee for the assignment of the Trademarks shall be TEN DOLLARS (\$10.00).




