## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This Release of Security Interests in Trademarks (“Release”) is made as of the 30th day of August, 2022 (the “Release Date”), by BANKUNITED, N.A., as Administrative Agent (the “Lender”) in favor of MASTER CONCESSIONAIR, LLC, a Florida limited liability company (the “Obligor”).

WHEREAS, pursuant to that certain Security and Pledge Agreement dated as of December 20, 2019 (as amended, modified, extended or restated from time to time, the “Security Agreement”; all capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement) by and among the Obligor, Lender, and others party thereto, Obligor granted to the Lender, for the ratable benefit of the holders of the Secured Obligations (“Secured Parties”), a continuing security interest in and continuing lien upon all Trademarks, including the trademarks and trademark applications listed on Schedule A attached hereto (collectively, “Trademark Collateral”); and

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Lender the Notice of Grant of Security Interest in Trademarks which was recorded on January 13, 2020 with the Trademark Assignment Recordation Branch of the U.S. Patent and Trademark Office, at Reel 6836, Frame 0920 (the “Trademark Security Agreement”).

WHEREAS, Lender, on behalf of the Secured Parties, has agreed to terminate, release and discharge its security interest in all the Trademark Collateral, including the trademarks and trademark applications subject to the Trademark Security Agreement listed on Schedule A.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender, on behalf of the Secured Parties, hereby agrees as follows:

Lender hereby terminates, cancels, discharges, and releases all of Lender’s security interests, liens, pledges, mortgages, and other encumbrances of any kind whatsoever created against the Trademark Collateral, including the trademarks and trademark applications listed on Schedule A.

This Release shall be governed by the laws of the State of Florida. This Release shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. This Release may be executed in any number of separate counterparts, each of which shall, collectively and separately, constitute one and the same instrument, and any signature page delivered by electronic transmission shall have same effect as the delivery of an original thereof.
