RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL**, dated as of September 2, 2022 (this “Release”), is made by GOLUB CAPITAL LLC in its capacity as administrative agent (“Agent”) in favor of NAMELY, INC., a Delaware corporation and NAMELY EMPLOYEE BENEFITS, LLC, a Delaware limited liability company (individually and collectively, the “Grantor”).

WITNESSETH

WHEREAS, pursuant to the Loan Agreement, Grantor executed the Intellectual Property Security Agreement, dated as of June 27, 2019 (the “Agreement”) and recorded with the U.S. Patent and Trademark Office on June 27, 2019 at Reel/Frame No. 6680/0652, pursuant to which Grantor granted and pledged to Agent for its benefit and the benefit of the Lenders a security interest in all of Grantor’s right, title and interest in, to and under the Intellectual Property Collateral (as defined in the Agreement).

WHEREAS, Grantor has requested that Agent release its security interest in and to all of its right, title and interest in, to and under the Intellectual Property Collateral.

NOW, THEREFORE, in consideration of the foregoing, Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Intellectual Property Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Intellectual Property Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to Grantor, without recourse, representation or warranty, any and all right, title and interest that Agent may have obtained in, to and under the Intellectual Property Collateral under the Loan Agreement and the Agreement.
