TRADEMARK ASSIGNMENT

This Trademark Assignment Agreement (this "Agreement") is made effective as of August 4, 2022, (the "Effective Date"), by and between Dive Technologies Inc., a Delaware corporation, having its principal office at 258 Willard Street, Quincy MA 02169, USA ("Dive"), and Anduril Industries, Inc. a Delaware corporation having its principal office at 1375 Sunflower Ave, CA 92626, USA ("Andurif"). Throughout this Agreement, Dive and Anduril may each be referred to as a "Party", or collectively, the "Parties."

RECITALS

WHEREAS, Dive owns the trademarks, together with their respective applications and registrations listed in Schedule 1, attached hereto (collectively, the "Marks").

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignment of the Marks to Anduril. ۱.

- 1.1 Assignment. The Dive irrevocably assigns, grants, and transfers to Anduril, all of the Dive's right, title, and interest in and to the Marks, including all common law rights, and any trademark registrations and applications, together with all of the goodwill associated with the Marks, and the right to sue third parties for and recover damages from future infringement of the Marks, the same to be held and enjoyed by Anduril for his own, exclusive use and enjoyment and the use and enjoyment of his successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Dive if this assignment had not been made (the "Assignment").
- Perfection of Ownership. To the extent that the Dive is seeking to perfect the 1.2 ownership of the Marks and the Dive's ownership of the Marks has not been perfected by the Effective Date, Dive agrees to promptly assign ownership of the Marks to Anduril, in accordance with the terms of this Agreement, as soon as such ownership has been perfected. Dive further agrees to take all steps necessary to promptly expedite any perfection of its ownership in and to the Marks. Dive hereby authorizes the Commissioner for Trademarks of the United States, and

- 2. <u>Payment</u>. In full consideration for the Assignment and the rights granted to Anduril by this Agreement, Anduril will pay to Dive a one-time payment in the grand total sum of <u>One Hundred U.S. Dollars (\$100.00)</u>.
- 3. <u>Representations and Warranties</u>. Each of Anduril and Dive represents and warrants that the individual signing this Agreement on its behalf is fully authorized to do so. Dive further represents and warrants that:
 - (a) it has not granted any person or entity any currently subsisting or future right, title, or interest in or to the Marks; and
 - (b) the Marks are not subject to any third-party lien or other encumbrance.
- 4. <u>Entire Agreement</u>. This Agreement contains the entire understanding of the parties as to its subject matter. This Agreement cannot be modified or otherwise changed except in a writing signed by both parties.
- 5. <u>Execution</u>. The Agreement may be executed in one or more counterparts, each of which will be deemed an original, all of which together will constitute one and the same instrument, without affecting the validity hereof. Scanned and/or electronic signatures shall be deemed binding for all purposes.




