RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of the date set out below ("Release"), is made by JPMorgan Chase Bank, N.A. (the "Lender"), in favor of Navegate Logistics, Ltd., a Minnesota corporation (the "Grantor").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby terminates and releases its continuing security interest in and continuing lien upon and all other rights in the Trademarks that Lender has, had, or could have had pursuant to the Security Agreement or otherwise and terminates the Notice. Lender hereby further authorizes Grantor or its assignees or successors in interest to take any and all actions, including filing and recording this Release with the USPTO or other appropriate governmental authorities to effectuate and further document the release made hereby.
