ASSIGNOR confirms that ASSIGNOR has sold, assigned and transferred to ASSIGNEE all of its worldwide right, title and interest of ASSIGNOR in and to the Patents and all reissues therefor and re-examination certificates therefor, and the inventions disclosed therein, and together with all causes of action (in law or equity), claims, demands and any other rights for, or arising from any past, present or future infringement, of the Patents, and the right to

sue for and collect any damages in connection with such assignment and transfer for the use and benefit of ASSIGNEE and ASSIGNEE's successors, assigns, and other legal representatives. And ASSIGNOR hereby authorizes and requests the Patent Office of the countries wherein said patent applications of the Patents are filed to issue to ASSIGNEE, its successors and assigns any and all letters patent which may be granted upon the Patents.

3. The parties confirm and hereby covenant that they will, at the Assignee's cost, execute and do all such further documents or things as may be reasonably required to give effect to this Agreement including the registration of the assignments provided for herein in the various worldwide Intellectual Property Offices.

4. ASSIGNOR covenants to ASSIGNEE, its successors, assigns and legal representatives, that the interest and property hereby conveyed is free from all prior assignment, grant, mortgage, license or other encumbrance by ASSIGNOR.


