

This Release of Security Interest in Trademarks (this "**Release**") is intended to operate as a release of all liens and security interests conveyed by the Companies to Lender pursuant to the terms of the Trademark Security Agreement, and to reassign to the applicable Companies all of Lender's right, title, and interest acquired pursuant to the terms of such Trademark Security Agreement.
