Please be advised that pursuant to that certain Amended and Restated Pledge and Security Agreement dated as of February 23, 2021 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among UNITED RADIO INCORPORATED, a Kentucky corporation (the "Grantor"), the additional entities party thereto from time to time and JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent (the "Administrative Agent") for the lenders party to the Credit Agreement referred to below (the "Lenders"), the undersigned have granted to the Administrative Agent, for the benefit of the Lenders, a continuing security interest in and to, and lien upon, all right, title, and interest in the trademarks and trademark applications set forth on Schedule 1 hereto:

The undersigned and the Administrative Agent hereby acknowledge and agree that the security interest in the foregoing trademarks may only be terminated in accordance with the terms of the Security Agreement.




