**GRANT OF SECURITY INTEREST
IN TRADEMARKS (THE “GRANT”)**

September 13, 2022

WHEREAS, BLUE BUCKET GROUP I LLC, a Delaware limited liability company, and **J. MANN, LLC**, a California limited liability company (collectively, the “Pledgors” and each, a “Pledgor”) are the owners of the trademark registrations listed on Schedule A attached hereto (all such trademarks and registrations, collectively, the “Trademarks”); and

WHEREAS, each Pledgor has entered into a Pledge and Security Agreement (as amended, modified, restated or supplemented from time to time, the “Security Agreement”), dated as of September 13, 2022, in which each Pledgor has agreed with **FIDUS INVESTMENT CORPORATION**, as Collateral Agent (the “Collateral Agent”), with offices at 1603 Orrington Avenue, Suite 1005, Evanston, IL 60201, to execute this Grant;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Pledgor hereby pledges, assigns and delivers to the Collateral Agent, for the ratable benefit of the Secured Parties, and grants to the Collateral Agent, for the ratable benefit of the Secured Parties, a Lien upon and security interest in, all of its right, title and interest in and to the Trademarks, including those set forth on Schedule A hereof, together with all Proceeds thereof. This Grant has been given in conjunction with the security interest granted to the Collateral Agent under the Security Agreement, and the provisions of this Grant are without prejudice to and subject to the provisions of the Security Agreement, which are incorporated herein by this reference.

THIS GRANT AND ANY CLAIMS, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS GRANT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK (WITHOUT REGARD TO THE CONFLICTS OF LAW PROVISIONS THEREOF). THE PROVISIONS OF SECTIONS 10.2 AND 10.3 OF THE CREDIT AGREEMENT (AS DEFINED IN THE SECURITY AGREEMENT) ARE INCORPORATED HEREIN BY REFERENCE, MUTATIS MUTANDIS.


