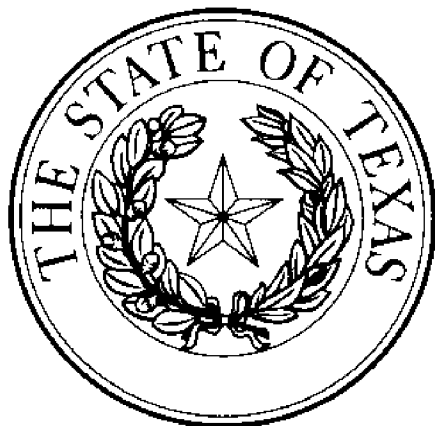

Because the attempted conversion was void and had no legal effect, it is my understanding that the subsequently attempted merger of For Fun Labs, Inc., a purported California corporation, into For Fun Labs, Inc., a Texas corporation, also was void, unsuccessful and legally ineffective.
