RELEASE OF SECURITY INTEREST (TRADEMARKS)

WHEREAS, the Grantor has requested that the Secured Party release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party hereby:

1. Releases to the Grantor any and all liens on and security interests in, and all right, title and interest of the Secured Party in and to, the Trademark Collateral, without recourse or representation or warranty, express or implied; and
2. Authorizes and requests the United States Patent and Trademark Office to note and record the existence of the release hereby given.
