## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this “Assignment”), is made effective as of September 27, 2022, by and between **American Cargo Group Trailers, LLC**, a Delaware limited liability company (“Assignor”), and **Trailer Group Holdings, Inc.**, a Nevada corporation (“Assignee”).



1. Assignment. Assignor hereby transfers, conveys and assigns to Assignee all of Assignor’s right, title, privileges and interest in and to the Marks, together with all goodwill appurtenant thereto, to be held and enjoyed by Assignee as fully and entirely as the same would have been held by Assignor had this Assignment not been made, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of the Marks, along with the right to sue for past infringements and collect same for Assignee’s sole use and enjoyment.
2. Cooperation in Transferring Marks. Assignor agrees to cooperate with Assignee and to follow Assignee’s reasonable instructions to effectuate the transfer of the Marks, and/or to correspond, as necessary, to authorize the transfer of the Marks with the United States Patent and Trademark Office. This Assignment, or a notice of this Agreement, or a redacted version of this Assignment, may be filed with the United States Patent and Trademark Office and such other government agencies, offices or authorities as required, necessary and/or appropriate.
2. Miscellaneous. This Assignment is binding on and shall inure to the benefit of the respective successors and/or assigns of Assignor and Assignee. This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware, and to the extent applicable, federal US law, without regard to conflict of laws principles. This Assignment may be executed in one or more counterparts, each of which shall be considered an original, but all of which taken together shall constitute one and the same instrument. This Assignment may be delivered by electronic means, including but not limited to email and facsimile.




