ASSIGNMENT OF CERTAIN INTELLECTUAL PROPERTY

This ASSIGNMENT OF CERTAIN INTELLECTUAL PROPERTY is made and entered into effective as of September 19, 2022 (the "Effective Date"), by and between CITADEL ARCHITECTURAL PRODUCTS, INC., a Delaware corporation ("Assignor") and CITADEL ARCHITECTURAL PRODUCTS, LLC, a Wisconsin limited liability company ("Assignee").

RECITALS

A. Assignor, Assignee, Scott R. Swisher, Brian Beresford, and Doug Huffman are parties to an Asset Purchase Agreement dated as of the Effective Date (the "Agreement"), pursuant to which Assignor has agreed to assign all of Assignor's right, title and interest in the trademarks as described on Schedule A attached hereto (the "Marks"), and goodwill associated with the Marks.

B. Each capitalized term used in this Assignment, if not otherwise defined herein, shall have the meaning ascribed thereto in the Agreement.

AGREEMENTS

In consideration of the recitals and the mutual agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby sells, assigns, conveys, transfers and delivers to Assignee, and Assignee hereby purchases, acquires and accepts from Assignor, all of Assignor's right, title and interest, including common law rights, in, to and under the Marks, and all applications and issued registrations with respect to same, as well as the goodwill related to the Marks. Assignor will execute any and all further documents reasonably necessary to transfer to Assignee title in and to the Marks.

2. This Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware without giving effect to its conflict of laws principle.

3. This instrument may be executed in counterparts in the original or by any generally accepted electronic means (including transmission of a pdf file containing an executed signature page or DocuSign), each of which shall be deemed an original and all of which shall constitute one and the same instrument.

4. The provisions of this Assignment are subject, in all respects, to the terms and conditions of the Agreement and all of the representations and warranties, covenants and agreements contained therein. For the avoidance of doubt, nothing in this Assignment will be deemed to supersede, enlarge or modify any of the rights or obligations of Assignor or Assignee under the Agreement. If any conflict exists between this Assignment and the Agreement, the Agreement will govern and control.


