
NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:



4. Cooperation. Assignee shall be responsible for, and Assignor shall cooperate in the execution and delivery of, any and all other instruments and papers and the taking of any and all additional actions necessary to effectuate the purposes and intent of the transaction provided for herein and otherwise to consolidate, vest and record in Assignee, full and complete ownership of the Trademarks;
5. Governing Law. This Assignment and any documents delivered in connection with this Assignment, will be governed by and construed, interpreted and enforced in accordance with the laws of the State of California.
6. Binding Effect. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors and other legal representatives, and shall be binding upon Assignor, its successors, assigns and other legal representatives.
