TRADEMARK SECURITY AGREEMENT

This Trademark Security Agreement is being entered into as of September 28, 2022, by and between NEON Rated, LLC, H and P Union, LLC, Hope and Perseverance, LLC, Brat Pack Movie, LLC, Cackle Bladder, LLC, Rise of the Players, LLC, Cuckoo Movie, LLC, Fresh Off the Bus, LLC, Stress Positions, LLC, Seeking MB Movie, LLC (each individually a “Grantor” and collectively, the “Grantors”), and Comerica Bank, in its capacity as the Administrative Agent under the Credit Agreement, as defined below.

RECITALS

This Trademark Security Agreement is being entered into in reference to the following facts:

A. Each Grantor now owns or holds and may hereafter adopt, acquire or hold Trademarks (defined as all of the following: all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade dress, logos, other source of business identifiers and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof or similar property rights, and all applications filed in connection therewith, including, without limitation, registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision of any thereof, and all reissues, extensions or renewals thereof) including, without limitation, the Trademarks listed on Schedule A annexed hereto, as such Schedule may be amended from time to time by the addition of Trademarks subsequently registered or otherwise adopted or acquired.

B. Pursuant to a Credit, Security, Guaranty and Pledge Agreement, dated as of September 28, 2022 (as may be amended, supplemented or otherwise modified, renewed, restated or replaced from time to time, the “Credit Agreement”) among NEON Rated, LLC, as Borrower (the “Borrower”), the Guarantors referred to therein, the Lenders referred to therein, and Comerica Bank, as the Administrative Agent and as the Issuing Bank, the Lenders agreed to make loans to the Grantor, and the Issuing Bank has agreed to issue, and the Lenders have agreed to participate in, Letters of Credit for the accounts of the Borrower. Initially capitalized terms used, but not defined herein, have the meanings set forth in the Credit Agreement);

C. Pursuant to the terms of the Credit Agreement, each Grantor has granted to the Administrative Agent (for the benefit of the Secured Parties) a security interest in and to all personal property of such Grantor including, without limitation, all right, title and interest of such Grantor in, to and under all of such Grantor’s Trademarks), whether now owned, currently existing or hereafter arising, adopted or acquired and whether or not in possession of such Grantor, together with the goodwill of the business connected with, and symbolized by, the Trademarks and all products and proceeds thereof and all income therefrom, including, without limitation, any and all causes of action which exist now or may exist in the future by reason of infringement or dilution thereof or injury to the associated goodwill, to secure the payment and performance of the Obligations.

D. The Administrative Agent and each Grantor by this instrument seek to confirm and make a record of the grant of a security interest in the Trademarks and the goodwill associated therewith.

NOW, THEREFORE, each Grantor hereby agrees as follows.

1. Security Interest Grant. The Grantor hereby grants to the Administrative Agent (for the benefit of the Secured Parties), as security for the Obligations, a continuing security interest in and to all of Grantor's right, title and interest in, to and under the following (all of the following items "(a) – (b)" or types of property being collectively referred to herein as the "Trademark Collateral"), whether now owned, presently existing or hereafter arising, adopted or acquired and whether or not in possession of Grantor:

a. each Trademark and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, including, without limitation, each Trademark referred to in Schedule A annexed hereto;

b. all products and proceeds of, and income from, any of the foregoing, including, without limitation, any claim by the Grantor against third parties for the past, present or future infringement or dilution of any, or for injury to the goodwill associated with any Trademark.

2. Credit Agreement Limitations.

a. The security interest granted pursuant to paragraph number 1 hereof is granted in conjunction with the security interests granted to the Administrative Agent (for the benefit of the Secured Parties) pursuant to the Credit Agreement.

b. The rights and remedies of the Administrative Agent (for the benefit of the Secured Parties) with respect to the security interest made and granted hereby are more fully set forth in the Credit Agreement, and are subject to the limitations (including certain rights of quiet enjoyment in favor of licensees) set forth in the Credit Agreement, the terms of which are incorporated by reference herein as if fully set forth herein.

3. Security Interest Termination.

a. This Trademark Security Agreement is made for collateral purposes only.

b. Upon the occurrence of the Facility Repayment Date the Administrative Agent (on behalf of the Secured Parties) shall execute and deliver to the Grantor, at the Grantor's request and expense, without representation, warranty or recourse, all releases and reassignments, termination statements and other instruments as may be necessary or advisable to terminate the security interest of the Administrative Agent (for the benefit of the Secured Parties) in the Trademark Collateral, subject to any disposition thereof which may have been made by the Administrative Agent pursuant to the terms hereof or of the Credit Agreement.

4. Governing Law. This Trademark Security Agreement shall in all respects be construed in accordance with, and governed by, the laws of the State of California and the

applicable federal laws of the United States of America, without regard to any conflict of laws principles that would result in the application of the laws of another jurisdiction.

5. Execution and Counterparts.

a. This Trademark Security Agreement, and any modifications or amendments hereto may be executed in any number of counterparts, each of which when so executed and delivered shall constitute an original for all purposes, but all such counterparts taken together shall constitute but one and the same instrument.

b. Delivery of an executed counterpart of a signature page of this Trademark Security Agreement by facsimile or transmitted electronically in a Tagged Image Format File ("TIFF"), Portable Document Format ("PDF") or other electronic format sent by electronic mail shall be effective as delivery of a manually executed counterpart of this Trademark Security Agreement. This Trademark Security Agreement shall become effective when it shall have been executed by each party hereto.

c. Any party delivering an executed counterpart of this Trademark Security Agreement by facsimile or by email shall also deliver a manually executed counterpart of this Trademark Security Agreement, but failure to do so shall not affect the validity, enforceability or binding effect of this Trademark Security Agreement, and the parties hereby waive any right they may have to object to said treatment.

6. Notices. All notices and other communications provided under this Trademark Security Agreement shall be delivered in such form, manner and address as provided in Section 15.1 of the Credit Agreement.

7. Partial Invalidity. Any provision of this Trademark Security Agreement which is invalid, illegal or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such invalidity, illegality or unenforceability without invalidating the remaining provisions hereof, and any such invalidity, illegality or unenforceability in any jurisdiction shall not invalidate or render unenforceable such provision in any other jurisdiction.

8. Amendments, Modifications and Waivers. No amendment, modification, rescission, waiver or release of any provision of this Trademark Security Agreement, and no consent to any departure therefrom shall in any event be effective unless signed by the Administrative Agent (whose signature shall be delivered only in accordance with the applicable provisions of the Credit Agreement) and the Grantor. Any waiver or consent shall be effective only in the specific instance and for the specific purpose for which it is given.

9. Successors and Permitted Assignees. This Trademark Security Agreement shall bind and inure to the benefit of the parties hereto and their successors and permitted assigns (as determined pursuant to the Credit Agreement), but neither this Trademark Security Agreement nor any of the rights or interests hereunder shall be assigned by the Grantor (including its successors and permitted assigns) without the prior written consent of the Administrative Agent (which shall be provided only in accordance with the applicable provisions of the Credit Agreement), and any attempted assignment without such consent shall be null and void.

10. Controlling Agreement. If any conflict or inconsistency exists between this Trademark Security Agreement and the Credit Agreement, the Credit Agreement shall govern.




