RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”), dated as of October 27, 2022, is made by Cortland Capital Market Services LLC, a Delaware limited liability company, as collateral agent (the “Collateral Agent”) in favor of Pawling Engineered Products LLC, a Delaware limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights dated as of November 5, 2021 made by Grantor in favor of Collateral Agent which was recorded with the United States Patent and Trademark Office on November 7, 2021 at Reel 007486, Frame 0651 (the “Trademark Security Agreement”), Grantor granted to Collateral Agent a continuing security interest in all of Grantor’s right, title, and interest in and to the Collateral (as defined in the Trademark Security Agreement), including the trademark registrations and applications set forth on Schedule 1 attached hereto (collectively, the “Trademark Collateral”).

WHEREAS, Grantor has requested and Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. Collateral Agent hereby terminates, extinguishes, cancels, releases and discharges any and all right, title and interest in and to the Trademark Collateral arising in connection with the Trademark Security Agreement and assigns, discharges, quit claims and relinquishes to Grantor any and all right, title and interest it has in and to the Trademark Collateral.


2. Further Assurances. Collateral Agent shall take all further actions, and provide to Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the release of liens contemplated hereby.

3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York, without regard to principles of conflicts of laws requiring application of the law of any other jurisdiction.
