TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “**Termination**”) is dated as of October 13, 2022, and made by **AP MA FUNDING LLC**, in its capacity as agent for itself and the other Secured Parties (in such capacity, “**Grantee**”), in favor of **OUTSOLVE, LLC f/k/a OUTSOLVE ACQUISITION, LLC**, a Delaware limited liability company (the “**Grantor**”).

WHEREAS, pursuant to that certain Grant of a Security Interest – Trademarks Agreement, dated November 1, 2016, by the Grantor in favor of Grantee (the “**Trademark Security Agreement**”), a security interest was granted by Grantor to Grantee in certain Collateral (as such term is defined in the Trademark Security Agreement), including the Trademarks (as such term is defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“**USPTO**”) on November 16, 2016 at Reel/Frame 5936/0769; and

WHEREAS, Grantee now desires to terminate and release the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement.


2. Release of Security Interest. Grantee hereby terminates the Trademark Security Agreement and terminates, releases and discharges the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Trademark Security Agreement, in the Collateral, including the trademarks listed on Schedule A hereto, and all associated goodwill, and, without representation, recourse or warranty whatsoever, reassigns, transfers and conveys to Grantor all right, title and interest of Grantee in the Collateral, including all associated goodwill, and any right, title or interest of Grantee in such Collateral shall hereby terminate, cease and become void.

3. Governing Law. This Termination and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
