TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the “**Agreement**”) is made and entered into as of October 18, 2022 (the “**Effective Date**”) between MetaSkillVerse, LLC, a Delaware limited liability company with a business address of 16192 Coastal Highway, Lewes, Delaware 19958 (“**Assignor**”), and Metaflo LLC, a Delaware limited liability company with a business address of 43824 20th St. West, #2616, Lancaster, CA 93539 (“**Assignee**”). Assignor and Assignee may individually be referred to herein as “**Party**” or together as “**Parties.**”

WHEREAS, Assignor is the owner of the entire right, title, and interest in and to the METAFLO trademark and the trademark applications and registrations set out below (collectively the “**Assigned IP**”); and

WHEREAS, Assignor desires to assign to Assignee all right, title, and interest in and to the Assigned IP together with the ongoing and existing business to which the mark pertains, and Assignee desires to accept the Assigned IP; and

WHEREAS, with respect to U.S. Trademark Application Serial No. 97368635 which is a pending intent-to-use application, Assignee is the successor to the ongoing and existing business of Assignor to which the Assigned IP relates.

NOW THEREFORE, in consideration of the recitals and of the mutual promises, representations, warranties and covenants hereinafter set forth in this Agreement, and other good and valuable consideration, it is hereby agreed as follows.

1. Assignment. Assignor hereby irrevocably contributes, conveys, transfers, and assigns to Assignee, its successors and assigns, any and all of Assignor’s right, title, and interest in and to the METAFLO trademark and all goodwill, intellectual property and industrial property rights related to the METAFLO trademark, including but not limited to the applications and registrations therefor, and all rights, interests, and protections that are associated with, similar to, or required for the exercise of, any of the foregoing, however arising, pursuant to the laws of any jurisdiction throughout the world, whether registered or unregistered, including any and all the following (the “**Assigned IP**”):
