**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN PATENTS AND TRADEMARKS**

WHEREAS Paige, LLC (f/k/a Premium Denim, LLC), a California limited liability company ("Borrower") executed that certain Loan Agreement dated July 13, 2012, as amended and restated by a Loan Agreement dated June 30, 2015 (the "Loan Agreement") in favor of U.S. Bank National Association, as Administrative Agent (the "Administrative Agent") and the Lenders from time to time party thereto.

WHEREAS, Borrower granted the Administrative Agent, for the benefit of the Lenders, under the terms of the Loan Agreement and pursuant to that certain Patent and Trademark Security Agreement dated July 13, 2012, that certain Amendment to Patent and Trademark Security Agreement dated September 26, 2013, that certain Second Amendment to Patent and Trademark Security Agreement dated June 14, 2019, executed by Borrower in favor of Administrative Agent, for the benefit of the Lenders, a continuing security interest (collectively, the "Security Interest") in favor of the Administrative Agent, in and to the Patents (as defined in the Security Agreement) and Trademarks (as defined in the Security Agreement), including without limitation the patents, patent applications, trademarks and trademarks applications listed on Schedule A hereto and all of the goodwill of the business connected with the use of, and symbolized by the Patents and Trademarks, as well as all proceeds and claims based on past, present, or future infringement thereof.

WHEREAS, the Patent and Trademark Security Agreement was recorded on July 18, 2012, at the United States Patent and Trademark Office at Reel/Frame 4824/0365;

WHEREAS, the Amendment to Patent and Trademark Security Agreement was recorded on September 26, 2013, at the United States Patent and Trademark Office at Reel/Frame 5118/0147;


WHEREAS, the Second Amendment to Patent and Trademark Security Agreement was recorded on June 28, 2019, at the United States Patent and Trademark Office at Reel/Frame 6680/0945;

WHEREAS, the Administrative Agent has agreed to terminate and release its Security Interest in all of the Patents and Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, (a) the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the intellectual property of Borrower, including the Patents and Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Patents and Trademarks, (b) the Administrative Agent hereby assigns, transfers and conveys to Borrower any interest in such intellectual property and the Patents and Trademarks, including the Security Interest and any other liens, and (c) the Administrative Agent and Borrower agree that the Security Interest is hereby terminated in its entirety and shall be of no further force and effect, in the case of each of clauses (a), (b) and (c), without recourse and without representation or warranty of any kind (express or implied).
