## ASSIGNMENT OF SERVICEMARKS, TRADEMARKS AND TRADE NAMES

THIS ASSIGNMENT OF SERVICEMARKS, TRADEMARKS AND TRADE NAMES, dated this 31st day of January, 2018, is by and between Freestyle Software Inc., a Delaware corporation (the “**Seller**”), and Freestyle Solutions Inc, a Delaware corporation (the “**Purchaser**”), pursuant to that certain Asset Purchase Agreement dated as of the date hereof, by and among Seller and Purchaser (the “**Purchase Agreement**”). Initially capitalized terms used and not otherwise defined herein shall have the meanings given to them in the Purchase Agreement.

### W I T N E S S E T H:

WHEREAS, pursuant to the Purchase Agreement, Purchaser will acquire all of the Seller's right, title and interest in, under and to the Assets, the Seller has agreed to execute such instruments as the Purchaser may reasonably request in order to more effectively assign, transfer, grant, convey, assure and confirm to Purchaser and its successors and assigns, or to aid and assist in the collection of or reducing to possession by the Purchaser, all of such Assets;

WHEREAS, Seller desires to transfer and assign to Purchaser, and Purchaser desires to accept the transfer and assignment of, all of the Seller's worldwide right, title and interest in and to those registered and unregistered domestic and foreign servicemarks, trademarks and trade names and registrations set forth in Schedule “A” attached hereto (the “**Marks**” and “**Registrations**”, respectively) and all associated goodwill therewith;

NOW, THEREFORE, for and in consideration of the mutual covenants contained herein and in the Agreement and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller hereby transfers and assigns to Purchaser, and Purchaser hereby accepts the transfer and assignment of, all of the Seller's worldwide right, title and interest in, to and under: (a) the Marks, (b) the Registrations and any and all other issued federal or state trademark or service mark registrations of the Marks which Seller may own; (c) any and all pending federal and state applications to register the Marks; (d) all common law rights in, to and under the Marks; (e) all other rights in, to and under the Marks, together with and including all goodwill of the business symbolized by the Marks; (f) any and all rights to royalties, profits, compensations, license fees or other payments or remuneration of any kind relating to the Marks, and/or the goodwill under the Marks; and (g) all claims or causes of action Seller has or may have in connection with the Marks including, but not limited to, the right to sue and recover damages for any and all past infringements of the Marks, the same to be held and enjoyed by the Purchaser, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the Seller had this Assignment not been made.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Marks shall be governed by and construed in accordance with the laws of the State of Delaware without regard to the principles of conflicts of laws thereunder.
