**INTELLECTUAL PROPERTY ASSIGNMENT**  
**(Recordable)**

This Recordable Trademark Assignment Agreement ("**Agreement**") is made by and between Xylo Inc., a Virginia corporation ("**Assignor**"), and MegaTel Merchant Services, a Virginia limited liability company with a principal business address of 9701 Metropolitan Ct, Suite B Richmond, VA 23236 ("**Assignee**") and is effective as of the last date listed in the signature block below (the "**Effective Date**").

**1. Assignment.** Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's right, title, good will, and interest in and to the following:

- (a) The trademarks, service marks, names, tradenames, logos, slogans, design rights, and other similar designations of source or origin pertaining to XYLO, together with the goodwill symbolized by any of the foregoing (the "Assigned Trademarks");
- (b) U.S. Trademark Serial No. 97219737 for the XYLO trademark; and
- (c) All rights of any kind whatsoever of Assignor accruing under the Assigned Trademarks under the applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world, including any and all rights to sue and collect damages, royalties, or payments for past, present, and future infringement, misappropriation, or other violation of the Assigned Trademarks.

**2. Relationship.** The parties acknowledge that Assignee is the successor of Assignor.

**3. Recordation.** The parties authorize the Commissioner for Trademarks and any other similar authority anywhere to record and register this Agreement upon request of either party.

**4. Successors and Assigns.** This Agreement shall be binding upon and shall inure to the benefit of the parties and their respective successors and assigns.
