INTELLECTUAL PROPERTY PURCHASE AGREEMENT

THIS INTELLECTUAL PROPERTY PURCHASE AGREEMENT ("*Agreement*") effective as of August 31, 2006 ("*Effective Date*"), is made by and between Gould Electronics, Inc. an Arizona corporation ("*Seller*"), and Nippon Mining and Metals Co., Ltd., a corporation organized under the laws of Japan ("*Purchaser*").

RECITALS

A. Seller owns intellectual property, including the patents listed on Schedule A and the trademarks listed on Schedule B; and

B. Purchaser wishes to purchase from Seller, and Seller wishes to sell to Purchaser, all of Seller's right, title and interest in and to the Intellectual Property (as defined below).

AGREEMENT

The parties hereto agree as follows:

1. Definitions

"*Intellectual Property*" means the Purchased Patents, Purchased Trademarks, all copyrights owned by the Seller, and all trade secrets, including know-how and confidential information, owned by the Seller.

"*Patent In Suit*" means U.S. Patent No. 5,674,596, which is the subject matter of Case No. 4:03-CV-02549-SBA, *Johnson & Johnston Associates, Inc. v. R.E. Service Co., Inc.* (N.D. Cal.)

"*Purchased Patents*" means the patents and patent applications listed on Schedule A, any other patents and patent applications owned by Seller except the Patent In Suit, any foreign counterparts or equivalents thereto, whether existing now or in the future, and including, but not limited to, patents of utility, improvement or addition, utility model and appearance and industrial design patents and inventors certificates, as well as divisionals, reissues, continuations (in whole or in part), renewals and extensions of any of the foregoing and any patents that may issue from any of the foregoing.

"*Purchased Trademarks*" means the trademarks and service marks listed on Schedule B and all other trademarks and trade names owned by the Seller.

2. Assignment Of Intellectual Property; License Back

(a) Seller hereby irrevocably sells, assigns, transfers and sets over to Purchaser all of Seller's right, title and interest in and to the Intellectual Property for Purchaser's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Seller if this assignment and sale had not been made, together with all income, royalties, damages or payments due or

payable as of the Effective Date or thereafter related to any of the foregoing, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Intellectual Property, with the right to sue for and collect the same for Purchaser's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives; *provided, however*, that nothing herein shall assign to Purchaser the right to sue for past infringement of the Patent In Suit, which right is retained by Seller.

(b) Purchaser hereby grants to Seller a non-exclusive, fully paid up, worldwide license under all of Seller's rights in and to the Intellectual Property as reasonably necessary for Seller to conduct Seller's business consistent with its business as conducted immediately preceding the Effective Date.

3. Payment

Within five (5) days after the Effective Date, Purchaser will pay Seller the sum set forth in Schedule C in United States Dollars.

4. Further Assurances

(a) Seller hereby irrevocably appoints Purchaser as the true and lawful attorney-in-fact of Seller on Seller's and Purchaser's behalf and in Seller's and/or Purchaser's name, place and stead, to execute any further documents or instruments and do any and all further acts that may be deemed necessary or desirable by Purchaser or its successors, assigns or other legal representatives, to effect the conveyance to the Purchaser and its successors, assigns and other legal representatives, of the right, title and interest whose conveyance is made hereby, and to enable such right, title and interest to be recorded in the United States and all foreign countries, and to enable Purchaser and its successors, assigns and other legal representatives to sustain or renew any Patents, and to maintain, perfect, support and protect the right, title and interest of Purchaser and its successors, assigns and other legal representatives, in and to the Intellectual Property and any registrations issued in connection therewith.

(b) Seller authorizes and requests the United States Commissioner of Patents and Trademarks and any other similar government authority to record Purchaser as owner of the Intellectual Property and issue any and all patents and registrations issued thereon to Purchaser, as Purchaser of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Purchaser and its successors, assigns or other legal representatives.

(c) As between Purchaser and Seller, Purchaser is responsible for recording the assignments made hereby as well as any preceding assignments of the Intellectual Property necessary or deemed advisable by Purchaser to record the complete chain of title to Purchaser.

(d) Seller shall provide Purchaser, its successors, assigns or other legal representatives, cooperation and assistance at Purchaser's request and expense (including the execution and delivery of any and all affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documentation) as may be reasonably required in the implementation or perfection of this Assignment to the extent reasonably possible by Seller.

5. Disclaimer

ALL INTELLECTUAL PROPERTY IS ASSIGNED TO PURCHASER UNDER THIS AGREEMENT AS-IS, WHERE-IS AND WITH ALL FAULTS. SELLER MAKES NO, AND DISCLAIMS ALL, WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, UNDER THIS AGREEMENT.

6. General Provisions

(a) This Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument.

(b) This Agreement is governed by and construed and interpreted in accordance with the laws of the State of Ohio.

(c) This Agreement contains the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements, written or oral, with respect to the subject matter hereof.


