Nunc Pro Tunc Corrective Assignment of Trademarks

This *Nunc Pro Tunc* Corrective Assignment of Trademarks is retroactively effective as of February 26, 2021 (“Effective Date”).

WHEREAS, FOXIT SOFTWARE INCORPORATED, a corporation organized and existing under the laws of California with an address at 41841 Albrae Street, Fremont, California 94538 (“Assignor”) is the beneficiary of a certain NUNC PRO TUNC TRADEMARK AGREEMENT (“Original Agreement”) between Assignor and CVISION TECHNOLOGIES, INC. (“CVISION”), which is attached as Exhibit A;

WHEREAS, the Original Agreement transferred certain trademark rights (“Original Transferred Trademarks”) from CVISION to Assignor;

WHEREAS, the Original Transferred Trademarks improperly included the mark CVIEW, which is subject to U.S. Registration No. 3,149,274 (the “CVIEW Mark”); and

WHEREAS, the proper transferee of the CVIEW Mark is and was SOFTWARES AI, LLC, a limited liability company organized and existing under the laws of Delaware with an address of 118-35 Queens Boulevard, 14th Floor, Forest Hills, New York 11375 (“Assignee”).

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for valuable and legally sufficient consideration, the receipt and legal sufficiency of which are hereby acknowledged, the Assignor does sell, assign, and transfer to the Assignee, the Assignor's entire right, title and interest to the trademarks used in conjunction with the Assignor's business related to the CVIEW Mark identified in Schedule 1 attached hereto, together with that part of the goodwill of the Assignor's business connected with and symbolized by said trademarks. The rights granted herein shall include the right to file, prosecute and enforce any foreign corresponding trademark application in any jurisdiction throughout the world. In addition, Assignee is hereby assigned the full right, title and interest to enforce the rights granted hereunder against any past, present and future infringer (except with respect to Assignor with respect to any past infringement) of any of the rights transferred hereunder and to collect all recovery from such enforcement.

Assignor represents and warrants to Assignee that Assignor is the owner of the trademarks and rights described above; that Assignor has the unrestricted right to make this assignment; and that Assignor has not previously assigned any of the foregoing trademarks or rights.
