ASSIGNMENT

WHEREAS, Sheng-yi Chang (hereinafter referred to collectively as “ASSIGNOR”) is the owner of the trademark “GP THUNDER” in classes 11 and 35 with Registration Number 5038921, filed on May 1, 2015.

WHEREAS, the above-referenced trademark “GP THUNDER” is referred to as TRADEMARK;

WHEREAS, Sheng-yi Chang, a U.S. citizen, may have certain right, title or interest in the TRADEMARK;

AND WHEREAS, PREMIERTEK, a California Corporation, having its principal address at 1500 S Milliken Ave, Unit J, Ontario, CA 91761 (hereinafter “ASSIGNEE”), wishes to acquire the entire right, title and interest in and to the TRADEMARK, as well as the right of action and all other rights, including the right to sue or otherwise bring action and to collect and receive damages therefrom, for past infringement thereof, and to collect reasonable royalties based on the rights thereof;

NOW THEREFORE, in the receipt of valuable consideration which is hereby acknowledged, ASSIGNOR does hereby sell, assign and set over to ASSIGNEE:

(i) the entire right, title, interest and goodwill in and to the TRADEMARK that ASSIGNOR has or may have, and trademarks claiming priority therefrom, and all United States Trademarks which may be granted thereon and all priority rights under all available International Agreements, Treaties and Conventions for the protection of intellectual property in its various forms in every participating country; and

(ii) any and all claims and demands that ASSIGNOR may have against any firm, person or corporation relating to the TRADEMARK including but not limited to, any claim of infringement or claim of provisional rights, whether heretofore or hereafter accrued, together with the right to retain for ASSIGNEE any and all sums that ASSIGNEE may obtain or recover as a result of the assertion or enforcement of any such claim or demand; and

ASSIGNOR hereby authorize and requests the United States Patent and Trademark Office, and any officials of foreign countries whose duty it is to issue trademarks on applications as aforesaid, to issue all trademarks to ASSIGNEE in accordance with the terms of this Assignment;

ASSIGNOR hereby covenant that ASSIGNOR has full right to convey the entire interest, and that ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith;
