**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN
TRADEMARKS**

This TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Termination and Release") is granted as of November 15, 2022 by U.S. Bank National Association, (the "Grantee") in favor of CAN Community Health, Inc., a Florida not for profit corporation (the "Grantor").

WHEREAS, the Grantor executed and delivered a Trademark Security Agreement dated as of March 3, 2021 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Grant"), granting the Grantee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office ("USPTO") on March 4, 2021, at Reel 7211, Frame 0688;

WHEREAS, in connection with the satisfaction and discharge of the Master Trust Indenture, dated as of December 30, 2020, by and between the Grantor and the Grantee, the Grantor has requested that the Grantee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the trademarks and trademark applications described in the Grant (collectively, the "Trademarks") as herein provided; and

WHEREAS, the Grantor has requested that the Grantee provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor's right, title and interest in, to and under (i) the Trademarks, including without limitation those trademarks and trademark applications identified in Exhibit A hereto, (ii) all proceeds and products of the Trademarks, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks or unfair competition regarding the same; and assigns, transfers and conveys to Grantor any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
