**CERTIFICATE OF MERGER

UNDER SECTION 1003 OF THE LIMITED LIABILITY COMPANY LAW

FIRST: The name and jurisdiction of formation or organization of each limited liability company and other business entity that is to merge is as follows:

THIRD: The name of the foreign limited liability company, which is to be the surviving company, and which is hereinafter sometimes referred to as the "surviving constituent limited liability company", is Turnils North America, LLC. The jurisdiction of its formation is the State of Delaware, and the date of its formation therein is July 9, 2013. The surviving constituent limited liability company has not filed an Application for Authority with the New York Department of State and will not conduct business in the State of New York until it has filed an Application for Authority with the Department of State to do so.

FOURTH: An Agreement and Plan of Merger has been approved and executed by each limited liability company and other business entity that is a party thereto.

FIFTH: The name of the surviving foreign limited liability company is: Turnils North America, LLC.

SIXTH: The future effective date of the merger, which does not exceed 30 days from the date of filing, is: December 31, 2013.

SEVENTH: The surviving foreign limited liability company may be served with process in this state in any action or special proceeding for the enforcement of any liability or obligation of the domestic business corporation previously amenable to suit in this state that is to merge and for the enforcement that is provided in the Limited Liability Company Law of the right of the shareholder of the domestic business corporation to receive payment for its interests against the surviving foreign limited liability company.

EIGHTH: Pursuant to Section 623 of the Business Corporation Law, Section 1005 of the Limited Liability Company Law or any applicable statute, the surviving foreign limited liability company will promptly pay to the shareholder of the domestic business corporation, the amount, if any, to which it shall be entitled under the provisions of the Business Corporation Law, the Limited Liability Company Law or any other applicable statute relating to the right of shareholders to receive payment for their interest.

NINTH: The Secretary of State of New York is designated as agent of the surviving foreign limited liability company upon whom process against it may be served. The address within or without this state to which the Secretary of State shall mail a copy of any process against the surviving foreign limited liability company served upon him or her is: c/o Hunter Douglas, Inc., 1 Blue Hill Plaza, Pearl River, NY 10965, Attention: General Counsel.

TENTH: This merger is permitted by the jurisdiction of formation of the foreign limited liability company and is in compliance therewith.

ELEVENTH: The Agreement and Plan of Merger is on file at a place of business of the surviving foreign limited liability company. The address of such foreign limited liability company is: Hunter Douglas, Inc., 1 Blue Hill Plaza, Pearl River, NY 10965, Attention: General Counsel.

TWELFTH: A copy of the Agreement and Plan of Merger will be furnished by the surviving foreign limited liability company on request and without cost to any person holding an interest in any other business entity that is to merge pursuant to such agreement.
