TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (“Assignment”) is dated as of March 1, 2022 (the “Effective Date”), by and between Tundraland Home Improvements LLC, a Wisconsin limited liability company (the “Assignor”) and Leaf Home Enhancements, LLC, a Delaware limited liability company (the “Assignee”).

WHEREAS, Assignor wishes to assign, and Assignee wishes to acquire, all of Assignor’s full and complete rights, title and interest in and to the Trademark Rights. **NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby irrevocably assigns, transfers, and conveys to Assignee, and Assignee hereby accepts from Assignor, all of Assignor’s full and complete rights, title and interest in and to the Trademark Rights in the United States, all rights appurtenant thereto, including any common law rights, together with the goodwill associated with the business symbolized by the Trademark Rights for the goods and services associated with the Trademark Rights.

Assignor further assigns to Assignee all rights to sue for, recover from and receive all damages, at Assignee’s discretion, as well as all rights to injunctive relief, damages and profits, due or accrued, occurring from past, present and future infringing or misappropriating use of the Trademark Rights, or other violations, or injury to the said goodwill by any third-party.

Assignor agrees to provide reasonable assistance to Assignee in connection with information and documentation that may be required for the transfer, assignment, and maintenance of the Trademark Rights.

This Assignment may be executed in two or more counterparts and shall be enforceable upon the exchange of executed counterparts by fax or e-mail. The separately executed copies shall each be deemed an original but all of which together shall constitute one and the same instrument and be binding on the Parties.
