RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) dated as of December 2, 2022 is executed by U.S. BANK NATIONAL ASSOCIATION, a national banking association (the “Bank”), in favor of PRIME THERAPEUTICS LLC, a Delaware limited liability company (the “Debtor”).

RECITALS

A. WHEREAS, pursuant to that certain Loan and Security Agreement dated July 25, 2014 (the “Loan Agreement”), by and among the Debtor and the Bank, the Debtor has granted to the Bank a security interest in and to all of the Debtor’s right, title and interest in and to certain the trademarks, service marks, trademark or service mark registrations, trade names, and trademark or service mark applications, including, without limitation, those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”);

B. WHEREAS, a Notice of Grant of Security Interest in Trademarks between the Debtor and the Bank was recorded in the United States Patent and Trademark Office (the “USPTO”) on September 26, 2014, at Reel 005369, Frame 0270, with respect to the trademarks listed on Exhibit A attached hereto; and

C. WHEREAS, the Bank wishes to terminate and release, without representation or warranty, its security interest in and to the Released Collateral as provided in this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby terminates and releases, without representation or warranty, its security interest in and to the Released Collateral, including all of Debtor’s right, title, and interest in, to and under all of the trademarks, service marks, trademark or service mark registrations, trade names, and trademark or service mark applications, whether now owned or at any time hereafter acquired, of Debtor that are registered with, or for which applications for registration have been filed with, the USPTO, including the trademarks listed on Exhibit A hereto, and all registrations and pending applications associated therewith.

The Bank acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Debtor. The Bank authorizes the Debtor to record this Release with the USPTO and other applicable registry at the sole expense of the Debtor and agrees to provide the Debtor with any information and additional authorization necessary to effect the release of the security interest in the Released Collateral.
