**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of November 10, 2022 ("Effective Date"), by **MIDTOWN MADISON MANAGEMENT LLC**, a Delaware limited liability company (as successor agent to **ELM PARK CAPITAL MANAGEMENT, LLC**, a Delaware limited liability company), in its capacity as agent for the Lender Group, as such term is defined in the below defined Credit Agreement (together with its successors and assigns in such capacity, "Grantee"), in favor of **DATABASE SOLUTIONS, INC. (d/b/a ACCUREG)**, an Alabama corporation (the "Grantor").

**WHEREAS**, reference is made to that certain Credit Agreement, dated as of September 24, 2020, (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among **ACCUREG HOLDINGS, INC.**, a Delaware corporation ("Parent"), the Grantor, as borrower, the other parties signatory thereto, the lenders identified on the signature pages thereof, and Grantee;

**WHEREAS**, Grantor entered into that certain Guaranty and Security Agreement, dated as of September 24, 2020 (the "Guaranty and Security Agreement");

**WHEREAS**, pursuant to the Guaranty and Security Agreement, Grantor and Grantee entered into that certain Trademark Security Agreement, dated as of September 24, 2020 (the "Trademark Security Agreement")

**WHEREAS**, pursuant to the Credit Agreement, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") on May 27, 2021 at Reel 7309, Frame 0394, in which Grantor granted to Grantee a security interest in all of the Grantor's right, title and interest in and to the "Trademark Collateral" (as such term is defined in the Trademark Security Agreement, the "Trademark Collateral"); and

**WHEREAS**, Grantee now desires to release its security interest in the Trademark Collateral, including the trademarks listed on **Schedule 1** hereto (the "Trademarks").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges the Trademark Security Agreement and its security interest and pledge in the Trademark Collateral, including the Trademarks, granted pursuant thereto. Grantee hereby reassigns to Grantor all right, title, and interest of Grantee in the Trademark Collateral pursuant to the Trademark Security Agreement.


2. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantor's expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby. Grantee hereby authorizes Grantor and any of their respective designees to file this Release with the United States Patent and Trademark Office.

3. This Release shall be subject to the provisions regarding choice of law and venue, jury trial waiver, and judicial reference set forth in Section 25 of the Guaranty and Security Agreement (as defined in the Trademark Security Agreement), and such provisions are incorporated herein by this reference, *mutatis mutandis*.
