SECURITY AGREEMENT

GRANT OF SECURITY INTEREST (TRADEMARKS)

Dated: As of July 29, 2022

The undersigned, a New York corporation (the "Grantor"), is obligated to **CITIZENS BANK, N.A.** (the "Secured Party") under that certain Credit Agreement, dated as of July 29, 2022, between the Grantor and the Secured Party (as the same may be amended, supplemented or otherwise modified from time to time), pursuant to which the Grantor has entered into a certain Pledge and Security Agreement, dated as of July 29, 2022, among the Grantor and Choice Logistics Delaware LLC, in favor of the Secured Party (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"). Capitalized terms used herein and not defined herein shall have the meanings assigned to such terms in the Security Agreement.

Pursuant to the Security Agreement, the Grantor granted to the Secured Party a security interest in and to all of the right, title and interest of the Grantor in all Intellectual Property of the Grantor including the trademarks listed on Schedule 1, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the prompt payment, performance and observance of the Secured Obligations.

For good and valuable consideration, the receipt of which is hereby acknowledged, and for the purpose of recording the grant of the security interest as aforesaid, the Grantor does hereby further assign to the Secured Party, and grant to the Secured Party a security interest in, the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Secured Party with respect to the assignment of and security interest in the Collateral made and granted hereby are set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
