## TRADEMARK ASSIGNMENT

2. Assignor authorizes Assignee, its successors and assigns to the fullest extent permitted by applicable law, to file in its own name applications for trademark and service mark registrations in connection with the Trademarks, and to secure in its own name the registrations granted thereon throughout the world.

3. Assignor agrees that, following the Effective Date, Assignee may record and register this Assignment with the relevant trademark registries and offices to effectuate Assignee’s ownership of the Trademarks.

4. This Assignment may be executed using electronic signatures in one or more counterparts, each of which shall be deemed an original, and all of which taken together shall constitute one and the same instrument. Photographic, facsimile, and/or scanned copies of such signed counterparts may be used in lieu of the originals of this Assignment for any purpose, and shall be deemed as effective as an original signature.

5. This Assignment will be governed by North Carolina law without giving effect to principles of conflict of laws.
