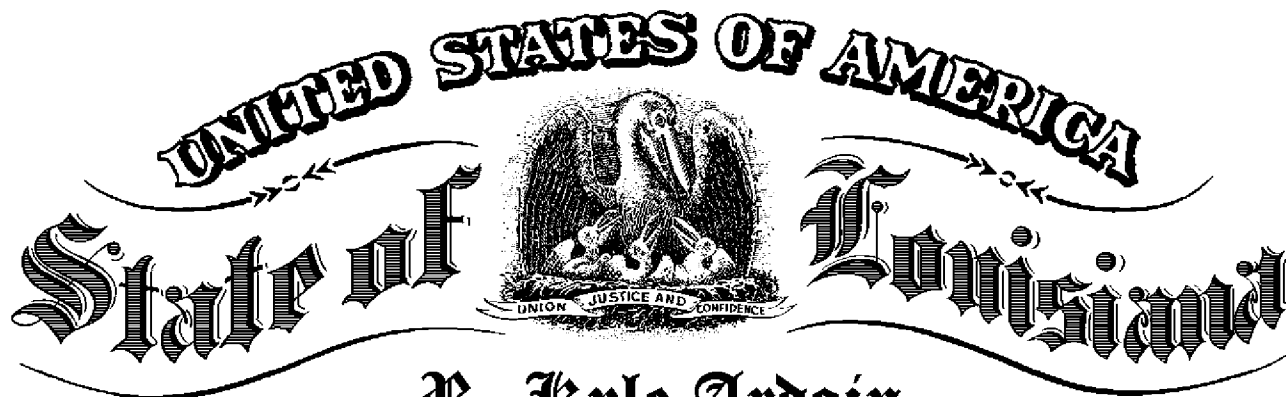

**ARTICLES OF ENTITY CONVERSION FOR  
GRIDSOURCE INCORPORATED**

**GRIDSOURCE INCORPORATED**, a Louisiana corporation, hereby executes the following application for conversion into a Louisiana limited liability company:

1. (a) The name of the converting entity is GridSource Incorporated.  
(b) The name of the surviving entity is GridSource Incorporated, LLC.
2. The surviving entity is a limited liability company.
3. The converting entity is continuing its existence in the organizational form of a limited liability company.
4. The outstanding shares of the converting entity shall be converted automatically upon the effectiveness of this application into membership interests of the surviving entity on an equal basis.
5. The conversion of GridSource Incorporated into a limited liability company has been authorized and approved by the shareholders in accordance with Louisiana Revised Statutes 12:1-953A, et seq and the articles of incorporation of the converting entity.
6. The Articles of Organization of the surviving entity are as follows:
  - a. Name. The name of the company is:

GridSource Incorporated, LLC
  - b. Purpose. The company may engage in any lawful activity for which limited liability companies may be formed under the Louisiana Limited Liability Company Law.
  - c. Management. The company shall be managed by its managers.
  - d. Certificate of Authority. Any manager of the company, in accordance with the provisions of La. R.S. 12:1305(C)(5) and with these Articles of Organization, is authorized to execute certificates which establish the membership of any member, the authenticity of any records of the company, and the authority of any person to act on behalf of the company, including but not limited to providing a statement of those persons or entities with the authority to take the actions referred to in La. R.S. 12:1318(B). No person dealing with a manager of the company shall be required to determine such manager's authority to make any such commitment or undertaking on behalf of the company or to determine any fact or circumstance bearing upon the existence of such manager's authority and shall be entitled to conclusively rely upon such certificates.

e. Member, Manager, and Officer Liability. No member, manager, or officer of the company shall be personally liable or bear any responsibility whatsoever for any of the debts, obligations, or liabilities of the company. No member or manager shall be personally liable to the company or its members for monetary damages for breach of any duty provided for in La. R.S. 12:1314; provided however, that nothing herein shall limit or eliminate the liability of a member or manager for (a) the amount of a financial benefit received by a member or manager to which he is not entitled; or (b) an intentional violation of a criminal law. If the Louisiana Limited Liability Company Law is hereafter amended to authorize limited liability company action further limiting or eliminating the personal liability of members or managers, then the liability of each member or manager of this company shall be limited or eliminated to the full extent permitted by the Louisiana Limited Liability Company Law. Neither the amendment nor repeal of this paragraph (e), nor the adoption of any provision of this company's Articles of Organization inconsistent with this paragraph (e) shall eliminate or reduce the effect of this paragraph (e), in respect of any matter occurring, or any cause of action, suit or claim that, but for this paragraph (e), would accrue or arise, prior to such amendment, repeal or adoption of an inconsistent provision.

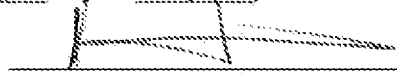
