



R.S. 12:1314; provided however, that nothing herein shall limit or eliminate the liability of a member or manager for (a) the amount of a financial benefit received by a member or manager to which he is not entitled; or (b) an intentional violation of a criminal law. If the Louisiana Limited Liability Company Law is hereafter amended to authorize limited liability company action further limiting or eliminating the personal liability of members or managers, then the liability of each member or manager of this company shall be limited or eliminated to the full extent permitted by the Louisiana Limited Liability Company Law.
