## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Agreement"), dated 12/19/2022, 2022 (the "Effective Date"), is made by and between Troy Deri Sanayi Ve Ticaret Limited Sirketi (the "Assignor or "Troy Deri"), a Turkish limited liability company and Leathertainment Media LLC (the "Assignee" or "Leathertainment"), a Texas limited liability company (hereinafter referred to collectively as the "Parties").

### RECITALS

WHEREAS, Troy Deri is located at Sakarya Mah Dericiler Cad No:36, Biga, Canakkale, Turkey, 17200 and is the owner of trademark application serial number 97423969 (the "Trademark") with the United States Patent and Trademark Office ("USPTO") for use in connection with entertainment services.

WHEREAS, Leathertainment is located at 1212 Dofton Dr., Suite 308, Dallas, Texas 75207.

WHEREAS, as of the Effective Date, the Trademark is awaiting examination by the USPTO as it was applied for by Assignor on May 23, 2022.

WHEREAS, the Assignor desires to assign Assignee as the new owner of the Trademark;

WHEREAS, the Assignee desires to acquire Assignor's right, title and interest in and to the Trademark, together with the benefit of any use of the Trademark by the Assignor, and the goodwill of the business relations of the Trademark and to the goods or services associated with it.

### AGREEMENT


**NOW THEREFORE**, in consideration of the foregoing, and for other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Parties hereto agree as follows:

1. Trademark Assignment. The Assignor hereby sells, transfers, and assigns to the Assignee, its successors and assigns, all of the Assignor's right, title and interest in the applied-for Trademark, together with (i) the benefit of any use of the Trademark by the Assignor, (ii) the goodwill of the business relations to the Trademark and to the goods or services associated with it, and (iii) any income, royalties, and damages hereafter agreed to be due or payable to Assignor with respect to the Trademark.
2. Ownership of the Trademark. Assignee shall be the one-hundred percent (100%), sole owner of the Trademark. Assignee shall be responsible to maintain the Trademark upon registration and to file appropriate maintenance documents with the USPTO indicating its continued use of the Trademark, when applicable.

3. Office Action. Assignee shall be solely responsible for the Trademark application, which shall include but is not limited to providing responses to any office actions issued by the USPTO examining attorney, or providing appropriate specimens indicating the use of the Trademark in commerce.


