RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of December 16, 2022 (this "Release") is made by The Bank of Nova Scotia, as Administrative Agent (the "Secured Party"), under the Trademark Security Agreement dated October 26, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Sabine's Collections Brands Ltd., which amalgamated into Sabine's Collections Ltd.
