SHENZHEN UVLED OPTICAL TECHNOLOGY CO., LTD., a limited liability company (Chinese name 深圳市钰创合成光电技术有限公司), “**Shenzhen Optical**”, (Also recorded as SHENZHEN UVLED TECHNOLOGY CO., LTD with UKIPO, USPTO and EUIPO’s)

Shenzhen Papes Optoelectronics Co., Ltd., a limited liability company (Chinese name 深圳市帕普雷斯光电有限公司), “**Shenzhen Papes**,”

Ouyang Chenyl, an individual whose Chinese passport number is [REDACTED] (“Chenyl”)

Dai Shufen, an individual whose Chinese passport number is [REDACTED] (“Shufen”),

Li Jianwu, an individual whose Chinese ID number is [REDACTED] (“Jianwu”)

Hu Hui, an individual whose Chinese ID number is [REDACTED] (“Hui”)

Collectively the “**Assignor**”

**AND**

LAHC US 1 LLC, incorporated in Delaware, United States of America with a registered address of 1209 Orange Street, Wilmington, Delaware, 19801, United States of America and (the “**Assignee**”).

**BACKGROUND**

**WHEREAS**, Assignor and Assignee are parties to that certain asset purchase agreement (the “**Asset Purchase Agreement**”) and Supply Agreement (the “**Supply Agreement**”) dated as of the Effective Date, pursuant to which the Assignor has agreed to convey, transfer and assign to the Assignee, among other assets, the Intellectual Property Assets of Assignor;

**WHEREAS**, Assignor owns all of the rights, title and interest in and to the Intellectual Property Assets (as defined herein), and, pursuant to the Asset Purchase Agreement and Supply Agreement, and has agreed to execute and deliver this Assignment, for recording with responsible entities or agencies in any applicable jurisdiction (collectively, the “**Agencies**”); and

**WHEREAS**, capitalized terms used but not otherwise defined in this Assignment shall have the meanings ascribed to such terms in the Asset Supply Agreement and Supply Agreement.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. **Assignment**. Assignor hereby irrevocably conveys, transfers and assigns to Assignee, and Assignee hereby accepts from Assignor, all of Assignor’s right, title and interest in and to the following (collectively, the “**Intellectual Property Assets**”):

(a) all Intellectual Property Assets of Assignor, defined as all Intellectual Property and Intellectual Property Registrations that are owned by Assignor and used or held for use in the conduct of the Business as currently conducted or proposed to be conducted, together with all (a) royalties, fees, income, payments, and other proceeds now or hereafter due or payable to Sellers with respect to such Intellectual Property, and (b) claims and causes of action with respect to such Intellectual Property or rights under Intellectual Property Agreements, whether accruing before, on, or after the Effective Date, including all rights to and claims for damages, restitution, and injunctive and other legal or equitable relief for past, present, or future infringement,

misappropriation, or other violation thereof.

(b) including those set forth on **Schedule A** attached hereto, including Trade Marks, Designs, Design Patents, Patents, Domains, unregistered Intellectual Property rights, and all issuances, extensions, and renewals thereof, together with the goodwill of the business connected with the use thereof and symbolized thereby;

(c) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(d) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(e) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on or after the Effective Date, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default of the foregoing, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. **Recordation and Further Actions**. Assignor hereby authorizes the officials of responsible Agencies to record and register this Assignment upon request by Assignee. Following the Effective Date, upon Assignee's reasonable request, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of the Intellectual Property Assets to Assignee, or any assignee or successor thereto.

3. **Terms of the Asset Purchase and Supply Agreements**. The parties hereto acknowledge and agree that this Assignment is entered into pursuant to the Asset

Purchase Agreement and Supply Agreement, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Intellectual Property Assets. The representations, warranties, covenants, agreements and indemnities contained in the Asset Purchase Agreement and Supply Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and Supply Agreement and the terms of this Assignment, the terms of the Asset Purchase Agreement and Supply Agreement shall govern and control.

**4. Governing Law.** This Agreement, including all exhibits and schedules attached hereto and any dispute arising therefrom, shall be governed by and construed in accordance with the internal laws of the State of Delaware without giving effect to any choice or conflict of law's provisions thereof to the extent such principles or rules would require or permit the application of the laws of any jurisdiction other than those of the State of Delaware or any other jurisdiction.

**5. Dispute Resolution.** The Parties will submit all disputes arising under this agreement to arbitration in Hong Kong before three (3) arbitrators: (a) one arbitrator selected by Buyer, (b) one arbitrator selected by the Seller Parties, (c) and one independent arbitrator of the American Arbitration Association ("AAA"). The independent arbitrator shall be selected by application of the rules of the AAA, or by mutual agreement of the Parties. No Party will challenge the jurisdiction or venue provisions as provided in this Section. Nothing contained herein shall effect either Party's right to seek and/or enforce equitable remedies, including, without limitation, injunctive relief, under this Agreement.


