- D. Borrower requests that Bank release, discharge, terminate and cancel its remaining security interest in and to the Patents and Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Bank, without recourse, representation or warranty of any kind or nature, hereby releases, discharges, terminates and cancels its remaining security interest in and to the Patents and Trademarks.

Bank authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release of Security Interest.
