RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of December 15, 2022, by CANADIAN IMPERIAL BANK OF COMMERCE ("**Lender**") in favor of CEIPAL CORP., a Delaware corporation ("**Ceipal**"), ZONIAK SOFTWARE, LLC, a Delaware limited liability company ("**Zoniak Software**") and PROCUREWISE CORP., a Delaware corporation (collectively with Ceipal and Zoniak Software, "**Grantor**") with its principal place of business located at 687 Lee Rd., Suite 208A, Rochester, NY 14606.

Recital

WHEREAS, Grantor granted to Lender a security interest in the trademarks described on Exhibit A attached hereto (the "**Intellectual Property**") under an Intellectual Property Security Agreement dated as of January 6, 2022, as amended from time to time (the "**IP Security Agreement**") and recorded with the U.S. Patent and Trademark Office on January 10, 2022, at Reel/Frame 7554/0502.

WHEREAS, Grantor has requested and Lender has agreed to release its security interest in the Intellectual Property and terminate the IP Security Agreement.

Agreement

Now, therefore, Lender agrees that it terminates and releases its security interest in the Intellectual Property, terminates the IP Security Agreement, and reassigns to Grantor all right, title, and interest of Lender in or to the Intellectual Property.
