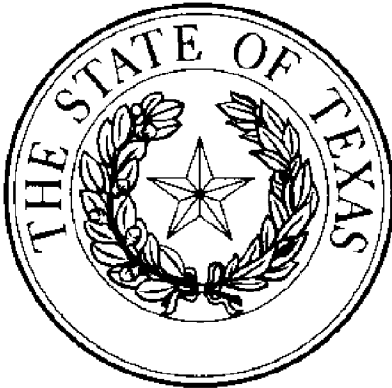

Pursuant to the provisions of Section 10.154 of the Texas Business Organizations Code, the undersigned hereby certifies that this Certificate of Conversion was adopted for the purpose of effecting the conversion of ToxStrategies, Inc., a Texas corporation (the "*Converting Entity*"), to a Delaware limited liability company named ToxStrategies, LLC (the "*Converted Entity*").

1. Converting Entity Information. The Converting Entity is ToxStrategies, Inc., a Texas corporation. The date of formation of the Converting Entity is December 26, 2007. The file number issued to the Converting Entity by the Secretary of State of the State of Texas is: 800914646.

2. Converted Entity Information. **CERTIFICATE OF FORMATION
OF
TOXSTRATEGIES, LLC**

I, the undersigned natural person of the age of eighteen (18) years or more, acting as organizer of a limited liability company under the Delaware Limited Liability Company Act, Title 6 Delaware Code, Chapter 18-101 *et. seq.*, do hereby adopt the following Certificate of Formation for such limited liability company:

1. Name. The name of the limited liability company formed hereby is ToxStrategies, LLC (the "***Company***").

2. Registered Office/Agent. The address of the registered office of the Company in the State of Delaware is 108 Lakeland Avenue, Dover, Delaware 19901, County of Kent, and the name of its registered agent at such address upon whom process against the Company may be served is Capitol Services, Inc.

3. Conversion. The Company has been converted to a Delaware limited liability company pursuant to Section 18-214 of the Delaware Limited Liability Company Act and that certain Agreement and Plan of Conversion of ToxStrategies, Inc. Prior to the conversion, the Company operated as a Texas corporation under the name ToxStrategies, Inc. (the "***Converting Entity***") since its date of organization on December 26, 2007. The Company constitutes a continuation of the existence of the Converting Entity in the form of a Delaware limited liability company.
