## ASSIGNMENT OF TRADEMARK RIGHTS

This ASSIGNMENT OF TRADEMARK RIGHTS (“**Assignment**”) is entered into by and between Arnold Cuervo, a United States individual, and Jesse Cohen, a United States individual, both with an address of 1400 SW 160th Ave., Miami, Florida 33196 (collectively, “**Assignors**”), and NBCUniversal Media, LLC, a Delaware Limited Liability Company, with an address of 30 Rockefeller Plaza, New York, New York 10112 (“**Assignee**”).

### AGREEMENT

1. Assignment. Assignors hereby assign to Assignee all right, title, interest, and goodwill in and to the Trademark and all related rights. Assignee accepts such assignment.

2. Execution and Delivery. Assignors agree to execute and deliver all papers, instruments and assignments and to perform any other reasonable acts the Assignee may require in order to vest all right, title, interest, and goodwill in and to the Trademark and any related rights to the Assignee and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate the assignment, to the extent such evidence is in the possession or control of Assignors.
