NOW, THEREFORE, for good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby irrevocably sell, convey, transfer, assign and deliver to Assignee all of Assignor's right, title and interest in and to the Marks and all issuances, extensions and renewals of the Marks, together with the goodwill of the business symbolized by the Marks and the portion of the business of the Assignor to which the Marks pertain, including: (i) all rights of Assignor arising under any of the foregoing under the law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world; (ii) all claims, causes of action and rights to sue and recover for any past, present or future infringement, dilution or unauthorized use of any of the foregoing; and (iii) all income, royalties, damages, fees, payments or proceeds accrued, due or payable as of the date hereof or hereafter with respect to any of the foregoing.

Assignor hereby authorizes the United States Patent and Trademark Office, and any foreign trademark office, to record and register this Assignment upon Assignee's request. Assignor hereby grants to Assignee and to the attorneys of record (now and in the future) for the Marks the power to insert on this Assignment any further identification information that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office, and any foreign trademark office, for recordation of this document. Assignor agrees, at the request of Assignee, to take or cause to be taken all such other actions, including the execution of any and all other instruments in writing, further applications, papers, affidavits, powers of attorney, assignments and other documents, which may be required, necessary, proper or advisable to more effectively secure to, and vest in, Assignee and its successors and assigns the entire right, title and interest in and to the Marks and otherwise to effectuate fully the purposes, terms and conditions of this Assignment.

This Assignment is binding upon and inures to the benefit of Assignor and Assignee and their respective successors and assigns. This Assignment shall be governed by and construed in accordance with the laws of the United States and the State of Delaware. In the event of a conflict between the Contribution Agreement and this Assignment, the Contribution Agreement shall govern.


