**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of January 24, 2023 by **JPMORGAN CHASE BANK, N.A.**, as Administrative Agent (the "*Assignee*"), in favor of **BENEFITFOCUS.COM, INC.** (the "*Grantor*"). Unless otherwise defined herein, capitalized terms used in this Termination and Release shall have the meanings assigned to such terms in the Grant (as defined below).

WHEREAS, the Grantor executed and delivered a Trademark Security Agreement dated as of August 17, 2022 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Grant*"), which was recorded with the United States Patent and Trademark Office ("*USPTO*") on August 18, 2022, at Reel 7825, Frame 0478;

WHEREAS, pursuant to (i) that certain Pledge and Security Agreement, dated as of August 17, 2022 (as amended, supplemented, restated, replaced or otherwise modified from time to time), entered into by the Grantor in favor of the Assignee, and (ii) the Grant, the Grantor pledged and granted to the Assignee, a security interest in all of the Grantor's right, title and interest in, to and under the Trademarks and all goodwill associated therewith, including those set forth on Schedule I hereto, Licenses in respect of any Trademark, and all proceeds and products of the foregoing and all insurance of the foregoing and proceeds thereof (collectively, the "*Trademark Collateral*"); and

WHEREAS, Assignee has agreed to terminate, release and discharge fully its security interests in and liens on the Trademark Collateral; and

WHEREAS, Grantor has requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee's security interests in and liens on the certain Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby agrees as follows:

1. Assignee hereby (i) terminates and cancels the Grant and (ii) absolutely, unconditionally and irrevocably cancels, releases, terminates and discharges all liens and security interests in the Trademark Collateral and all other liens and security interests that the Assignee or its successors and assigns may have in, to or on the Trademark Collateral, including in those certain Trademarks identified in Schedule I hereto.
2. Assignee represents and warrants that it has full authority to execute and deliver this Termination and Release.
3. Assignee hereby authorizes and requests that this Termination and Release be recorded at the USPTO.

4. This Termination and Release may not be supplemented, altered or modified in any manner except by a writing signed by all parties hereto. This Termination and Release shall be binding upon the Assignee's successors and assigns and is made in favor of and for the benefit of the Grantor and its successors and assigns.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
